QUARTERLY REPORT ON ACTIVITIES June 2023

Copper Strike Limited (“**Copper Strike**” or the “**Company**”) provides an update on its activities for the quarter ending 30 June 2023.

Corporate Strategy

Following the sale of remaining shareholding in Syrah Resources Limited (“**Syrah**”) in the previous quarter, Copper Strike is continuing its strategy of actively seeking project acquisition opportunities across a range of commodities and sectors. The sale of the Syrah investment has put the Company in a strong financial position to progress an acquisition for when the right opportunity is presented, as it will likely mean minimal future dilution to existing shareholders. The Company will keep shareholders informed of progress and will make an appropriate announcement when it is able to do so.

Suspension from Quotation – Compliance with Listing Rule 12.1

ASX notified the Company that it would suspend the Company’s securities from official quotation, and the securities of the Company were suspended at the close of trading on 12 December 2022 under Listing Rule 17.3.

Resignation of Joint Company Secretary

Mr Stefan Ross tendered his resignation as Joint Company Secretary on 11 May 2023. Mr Chris Bath continues in his role as Company Secretary.

Cash Balance

At the end of the quarter, Copper Strike had approximately \$19.3 million in cash and cash equivalents.
