QUARTERLY REPORT ON ACTIVITIES JUNE 2024

Copper Strike Ltd (“**Copper Strike**” or the “**Company**”) provides an update on its activities for the quarter ending 30 June 2024.

Capital Return

During the quarter the Company completed a capital return of \$0.0685 per share (**Capital Return**), which represented a cash payment of \$9.2 million. Shareholders approved the Capital Return at a general meeting held on 5 April 2024. The payment date for the Capital Return was 19 April 2024.

The payment of Capital Return and the fully franked dividend paid in March 2024 and represents a total cash return to Shareholders of approximately \$10 million (\$0.0745 per share) in the second half of this financial year and takes the total cash paid to shareholders during the financial year to approximately \$13 million (\$0.0969 per share).

Corporate Strategy

The Company continues to review project acquisition opportunities across a range of commodities and sectors. The Company will keep shareholders informed of progress and will make an appropriate announcement when it is able to do so.

Suspension from Quotation – Compliance with Listing Rule 12.1

ASX notified the Company that it would suspend the Company’s securities from official quotation, and the securities of the Company were suspended at the close of trading on 12 December 2022 under Listing Rule 17.3.

Cash Balance

At the end of the quarter, Copper Strike had approximately \$4.4 million in cash and cash equivalents.

Payments to related parties and their associates during the quarter totalled \$30,525, as outlined in Section 6.1 of the accompanying Appendix 5B.
